


## The CO<sub>2</sub> Challenge for Ethanol Refiners

Bioethanol Refineries coproduce large amounts of high-purity CO<sub>2</sub>

But CO<sub>2</sub> supply in the U.S. exceeds market demand by 5x

Resulting in a very low market price for CO<sub>2</sub>





## **Our Solution**

**Feedstocks** 

Upgrade the value of  $CO_2$  by 50 times (\$20 -> \$1000/ton) into a zero-carbon chemical and fuel at a 30% lower cost than existing fossil-based synthesis routes

**Product** 

\$20/ton

CH<sub>2</sub>O<sub>2</sub>

Formic Acid

\$1000/ton

OCO's FA process and product qualify for up to \$247/ton\_CO<sub>2</sub> tax credits (e.g. 45Q)






## **Commercialization Traction**
