ORDER GRANTING BLANKET AUTHORIZATION TO  
IMPORT AND EXPORT NATURAL GAS  
FROM AND TO MEXICO

DOE/FE ORDER NO. 4534

MAY 13, 2020

## I. DESCRIPTION OF REQUEST

On May 4, 2020, Sempra Gas & Power Marketing, LLC (Sempra Gas & Power Marketing) filed an application with the Office of Fossil Energy (FE) of the Department of Energy (DOE) under section 3 of the Natural Gas Act (NGA)<sup>1</sup> for blanket authorization to import 100 billion cubic feet (Bcf) of natural gas from Mexico, and to export 300 Bcf of natural gas to Mexico by pipeline. The applicant requests the authorization be granted for a two-year term beginning on August 1, 2020.<sup>2</sup> Sempra Gas & Power Marketing is a Delaware limited liability company with its principal place of business in San Diego, California.

## II. FINDING

The application has been evaluated to determine if the proposed import and export arrangements meet the public interest requirement of section 3 of the NGA, as amended by section 201 of the Energy Policy Act of 1992 (Pub. L. 102-486). Under section 3(c), the import and export of natural gas, including liquefied natural gas (LNG), from and to a nation with which there is in effect a free trade agreement requiring national treatment for trade in natural gas and the import of LNG from other international sources are deemed to be consistent with the public interest, and applications for such imports and exports must be granted without modification or delay. The authorization sought by Sempra Gas & Power Marketing to import and export natural gas from and to Mexico, a nation with which a free trade agreement requiring national treatment for trade in natural gas is in effect, meets the section 3(c) criterion and, therefore, is consistent

with the public interest. This Order authorizes transactions with terms of not greater than two years.

### ORDER

Pursuant to section 3 of the NGA, it is ordered that:

A. Sempra Gas & Power Marketing is authorized to import 100 Bcf of natural gas from Mexico, and to export 300 Bcf of natural gas to Mexico, pursuant to transactions that have terms of not greater than two years. This authorization shall be effective for a two-year term beginning on August 1, 2020, and extending through July 31, 2022.

B. This natural gas may be imported or exported by pipeline at any point on the border between the United States and Mexico.

C. **Monthly Reports:** With respect to the natural gas imports and exports authorized by this Order, Sempra Gas & Power Marketing shall file with the Office of Regulation, Analysis, and Engagement, within 30 days following the last day of each calendar month, a report indicating whether imports or exports of natural gas have been made. Monthly reports must be filed whether or not initial deliveries have begun. If no imports or exports have been made, a report of “no activity” for that month must be filed. If imports or exports of natural gas have occurred, the report must give the following details: (1) for imports, the country of origin; (2) for exports, the country of destination; (3) the point(s) of entry and exit; (4) the volume in thousand cubic feet (Mcf); (5) the average purchase price of gas per million British thermal units (MMBtu) at the international border; (6) the name of the supplier(s); (7) the name of the U.S. transporter(s); (8) the estimated or actual duration of the supply agreement(s); (9) for imports, the geographic market(s) served (list State(s), U.S. Census Region(s), or general U.S. geographic area(s)).

D. The first monthly report required by this Order is due not later than September 30, 2020, and should cover the reporting period from August 1, 2020 through August 31, 2020.

E. All monthly report filings on Form FE-746R shall be made to the U.S. Department of Energy (FE-34), Office of Fossil Energy, Office of Regulation, Analysis, and Engagement, according to the methods of submission listed on the Form FE-746R reporting instructions available at <https://www.energy.gov/fe/services/natural-gas-regulation>.
