SABINE PASS LIQUEFACTION, LLC
FE DOCKET NO. 20-28-LNG

PROPOSED ACTION DESCRIPTION: Sabine Pass Liquefaction, LLC (SPL), a Delaware limited liability company with its primary place of business in Houston, Texas, filed an application (Application) with the Office of Fossil Energy (FE) on March 10, 2020, seeking blanket authorization to engage in exports of liquefied natural gas (LNG) previously imported into the United States from foreign sources. SPL requests authorization to export this LNG in a volume equivalent to 500 billion cubic feet of natural gas, on a cumulative basis, for a two-year period commencing on June 7, 2020. As relevant here, SPL seeks to export the LNG by vessel from the existing Sabine Pass LNG Terminal (Terminal), owned by Sabine Pass LNG, L.P., and located in Cameron Parish, Louisiana, to any country with which the United States does not have a free trade agreement (FTA) requiring national treatment for trade in natural gas, and with which trade is not prohibited by U.S. law or policy (non-FTA countries). The Application was submitted pursuant to section 3 of the Natural Gas Act and 10 CFR Part 590 of the Department of Energy's (DOE) regulations.

In prior proceedings, DOE has conducted a NEPA analysis for non-FTA exports from the Terminal that cover all facilities associated with the Application. No new facilities or modification to any existing facilities at the Terminal are required in order for SPL to export the requested volume of LNG as a result of approval of the Application. DOE/FE's proposed action is to authorize the exports described in the Application if DOE/FE determines that such exports are not inconsistent with the public interest. If granted, the authorization would permit the requested LNG exports by vessel on a short-term basis from the Terminal, subject to certain terms and conditions set forth in the DOE order.

] There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

] The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer, I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
