Notification of Name Change

Dear Ms. Moore:

On February 2, 2009, DECP submitted an application in Docket No. 09-06-LNG requesting a short-term blanket authorization to import liquified natural gas (LNG) from various international sources by vessel in volumes up to the equivalent of 36 billion cubic feet (Bcf) per year of natural gas for a period of two years. DOE/FE granted DECP's request in Order Nos. 2612 (February 9, 2009), 2878 (November 8, 2010), 3223 (January 18, 2013), 3572 (December 31, 2014), 3971 (January 17, 2017), 3971-A (August 4, 2017), and 4320 (December 11, 2018).

On September 1, 2011, Dominion Energy Cove Point LNG, LP (DECP) submitted an application in Docket No. 11-115-LNG seeking authority to export LNG by vessel in volumes up to the equivalent of 365 Bcf per year of natural gas to free trade agreement (FTA) countries for a term of 25 years. DOE/FE granted DECP's request in Order Nos. 3019 (October 7, 2011), 3019-A (August 4, 2017), and 3019-B (October 21, 2020).

On October 3, 2011, DECP submitted an application in Docket No. 11-128-LNG seeking authority to export LNG by vessel in volumes up to the equivalent of 281 Bcf per year of natural gas to non-free trade agreement (non-FTA) countries for a term of 20 years. DOE/FE granted DECP's request in Order Nos. 3331 (September 11, 2013), 3331-A (May 7, 2015), 3331-B (April 18, 2016), 3331-C (August 4, 2017), and 3331-D (October 21, 2020).

Finally, on November 23, 2016, DECP submitted an application in Docket No. 16-205-LNG requesting a short-term blanket authorization to engage in exports of LNG by vessel in volumes up to the equivalent of 250 Bcf per year of natural gas for a period of two years. DOE/FE granted DECP's request in Order Nos. 4046 (June 2, 2017), 4046-A (August 4, 2017), and 4508 (February 28, 2020).



On July 9, 2020, DECP notified the DOE a planned transaction in which Berkshire Hathaway Energy Company (BHE), an Iowa corporation and a subsidiary of Berkshire Hathaway Inc., a Delaware corporation, will acquire indirect ownership and control of one hundred percent (100%) of the general partnership interests of DECP, and twenty-five percent (25%) of DECP's limited partnership interests. On September 30, 2020, the DOE subsequently granted the change in control.

On November 2, 2020, DECP amended its Certificate of Limited Partnership with the State of Delaware to change the limited partnership's name to Cove Point LNG, LP ("Cove Point" or CPL). Attached hereto is a copy of the Delaware issued certificate verifying the name change and its effective date.

On behalf of Cove Point LNG, LP, BHE as the operating partner, respectfully requests that the DOE/FE Order Nos. 4320, 3019 (as amended by 3019-A and 3019-B), 3331 (as amended by 3331-A, 3331-B, 3331-C, and 3331-D), and 4508 be amended to reflect Cove Point LNG, LP as the holder of such authorization, and that DOE/FE grant any waivers necessary to allow the name change to be effective as of the date set forth of the attached certificate.
