Name Change of G2 LNG LLC**

To: Office of Oil and Gas Global Security and Supply

On March 19, 2015, G2 LNG LLC (“G2 LNG”) filed its application for authorization to export liquefied natural gas (“LNG”) for a 30-year term to any country with which the United States does not have a free trade agreement requiring national treatment for trade in natural gas and LNG, but with which trade is not prohibited by United States law or policy, and that currently has—or in the future develops—the capacity to import LNG (“Non-FTA Application”).

As of the date of this letter, the U.S. Department of Energy (“DOE”) has not issued an order on the merits of G2 LNG’s Non-FTA Application.

On August 5, 2020, G2 LNG amended its Certificate of Formation with the state of Delaware in which the limited liability company’s name has been amended to G2 Net-Zero LNG LLC. This is strictly a name change. There has been no change in the corporate structure of the limited liability company, nor does this name change result in a change in control.

Accordingly, pursuant to 10 C.F.R. § 590.204(a) (2020), all references to “G2 LNG LLC” in the Non-FTA Application should be changed to “G2 Net-Zero LNG LLC.” G2 LNG respectfully requests that the DOE accept this notice as an amendment to the Non-FTA Application for the purpose of reflecting this name change. In accordance with DOE procedures, attached hereto is a copy of the Delaware-issued certificate verifying the name change and its effective date.
