American Recovery and Reinvestment Act:

The Alturas Indian Rancheria of California proposes to retrofit one home with energy appliances, insulated windows, insulated doors, energy efficient lighting, attic insulation, and an energy efficient roof. Insulated doors would also be installed at the tribal office and current appliances would be replaced with energy efficient appliances.
