Based on my review of the information concerning the proposed action, as NEPA Compliance Officer (authorized under DOE Order 451.1A), I have made the following determination:

Description:

B5.1 Actions to conserve energy, demonstrate potential energy conservation, and promote energy-efficiency that do not increase the indoor concentrations of potentially harmful substances. These actions may involve financial and technical assistance to individuals (such as builders, owners, consultants, designers), organizations (such as utilities), and state and local governments. Covered actions include, but are not limited to: programmed lowering of thermostat settings, placement of timers on hot water heaters, installation of solar hot water systems, installation of efficient lighting, improvements in generator efficiency and appliance efficiency ratings, development of energy-efficient manufacturing or industrial practices, and small-scale conservation and renewable energy research and development and pilot projects. The actions could involve building renovations or new structures in commercial, residential, agricultural, or industrial sectors. These actions do not include rulemakings, standard-settings, or proposed DOE legislation.

Rational for determination:

DOE is proposing to provide \$405,000 in EECBG funding to the Louisville Jefferson County Metro Government to replace the roof at a 17,000 square-foot warehouse located at 635 Industry Road, Louisville, Kentucky 40208. The roof would be replaced with a white, Energy Star roof designed to conserve water.

The proposed project would consist of replacing the old roof with a uniform layer of rigid insulation. The added insulation would reduce the heating and cooling costs associated with the facility. The existing roof would be removed down to the deck. The deck would not be replaced or modified. The storm water from the roof would be collected and sent to a new rain garden system, which would allow for natural drainage into the ground rather than the sewer system.

The proposed site is located in an industrial zone. The site is not in a wetland or floodplain, nor are threatened and endangered species known to occur in the area. The building was constructed in 1920. On July 13, 2011, SHPO determined "No Adverse Effect" on historic properties because no part of the project would be visible from the ground level.

Based on this information, DOE has determined that the work outlined is consistent with activities identified in Categorical Exclusion B5.1 (actions to conserve energy).
