Proposed Action Title: (0471-1539) Pacific Northwest National Laboratory - Electric-Powered Adsorption Heat Pump for Electric Vehicles

Program or Field Office: Advanced Research Projects Agency - Energy

Location(s) (City/County/State): Florida, Washington

Proposed Action Description:

Funding will support development of "EMOFs," a new class of advanced nanoporous metal-organic frameworks (MOFs) that can be regenerated electrically for use in future high efficiency electric vehicle (EV) heat pumps.

Proposed work consists of indoor laboratory-based research and development, modeling, and analysis, including (1) literature review, (2) synthesis, characterization, and development of various MOF materials, (3) testing and optimization of select EMOF materials in a prototype electrochemical cell, and (4) and EV heat pump prototype design, modeling, performance analysis, and cost analysis. Project work will take place at dedicated laboratory or office facilities located at Pacific Northwest National Laboratory (Richland, WA) and the University of South Florida (Tampa, FL).

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion. This proposal is not connected to other actions with potentially significant impacts (40 CFR 1508.25(a)(1)), is not related to other actions with individually insignificant but cumulatively significant impacts (40 CFR 1508.27(b)(7)), and is not precluded by 40 CFR 1506.1 or 10 CFR 1021.211 concerning limitations on actions during preparation of an environmental impact statement.

Based on my review of the proposed action, as NEPA Compliance Officer (as authorized under DOE Order 451.1B), I have determined that the proposed action fits within the specified class(es) of action, the other regulatory requirements set forth above are met, and the proposed action is hereby categorically excluded from further NEPA review.
