# Rational for determination:

This NEPA determination applies to an additional location for a mock roof installation associated with Hudson Valley Community College Northeast Photovoltaic Regional Training Provider project (GFO-10-237; CX A9, A11 and B5.1; signed 3.4.2010) applied to Phase 1. This additional location is also part of Phase 1.

Hudson Valley Community College's sub-recipient Three Rivers Community College (TRCC) proposes to use federal funding to purchase equipment for a mock roof system to support the solar photovoltaic (PV) educational "Train the Trainer" program, Two Lab Volt units would be purchased and installed inside of the Electrical Engineering Credit lab. The proposed project would be conducted at TRCC's campus (574 New London Turnpike, Norwich, Connecticut 06360) located 1.5 miles southeast of Norwich. The proposed site is east of a residential area, north of a Norwich Country Club and west of an open space.

TRCC's educational program would allow students to assemble mock solar PV systems (8 feet X 8 feet) installations for training purposes. The Lab Volt units would also be used for training purposes. Project activities would also include curriculum development and outreach activities.

Based on this information, DOE has determined the work outlined is consistent with activities identified in categorical exclusion A9 (information gathering, analysis and dissemination), A11 (technical advice and assistance to organizations) and B3.14 (small-scale educational facilities).
