Rational for determination:

The U.S. Department of Energy (DOE) provided \$547,000 of federal funding to the State of Louisiana Department of Natural Resources (DNR) under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. The DNR will match the federal funding with \$109,400 in state funds. Additionally, the DNR will carry over \$28,248 in Recovery Act SEP funds.

The DNR proposes to fund the following market titles:

Administration and Supervision:

Under this Market Title, federal funding would be used to administer and supervise the State Energy Program.

Revolving Loan Fund:

Under this Market Title, federal funding would continue to be used for a revolving loan fund that would finance costeffective energy efficiency improvements in private, public, and commercial/industrial facilities. This Market Title has been previously CX'd from further NEPA review. Any projects funded under this Market Title that do not remain within the bounds of DNR's Template for Expedited NEPA Review will be submitted for additional NEPA review.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact the human environment and they are categorically excluded from further NEPA review under CX A9 "information gathering" and CX A11 "technical advice." Any activities funded under the 2012 annual appropriations that involve ground-breaking activities, retrofits, or equipment purchase and/or installation are conditioned pending additional NEPA review.
