

Success in Meeting Small Business Goals

- EM FY 2010 and FY 2011 Small Business goal is 5%.
- Awarded over \$481M in Recovery Act funds to EM small business prime contractors.
- Awarded over \$700M in RA funds to small business subcontractors.
- Small business subcontracts continue to be awarded with Recovery Act funding. (No prime contracts in 2011)
- Small business contracts executing well!
- EM awarded over \$900 million in potential contracts to an Indefinite Delivery Indefinite Quantity (IDIQ) pool of small business contractors in 2010.

- Considerable subcontracting expected to meet EM small business goals

EM FY 2011 small business prime contracting goal = \$310 Million (5.0%)

- DOE's small business subcontracting goals for FY 2010 and FY 2011:

Woman-Owned Small Business	5.0 %

Real Small Business Stories

- How Quest® Environmental & Safety Products, Inc. Benefited from ARRA Projects with its Q-Gard Quantumwear® PPE Suit.

- Quest® Environmental & Safety Products, Inc., a Small Disadvantaged Business in Fishers, IN, an Indianapolis suburb, was able to successfully accelerate the market acceptance of its new invention, Q-Gard Quantumwear®, through the ARRA to help DOE workers fulfill their D and D activities in a safer and more comfortable manner, reduces added suits/ waste and adds efficiency to operations.

- Idaho Site Awards over \$46 Million in Recovery Act Funds to Small Businesses

- IDAHO FALLS, Idaho – Appropriately matching knowledgeable and skilled small businesses with projects accelerated with Recovery Act funding was a priority for the Idaho site to ensure workers would achieve cleanup milestones as they demolish facilities and process and remove contaminated waste from Idaho.
- To date, the Idaho site's main cleanup contractor, CH2M-WG Idaho (CWI) has awarded more than \$46 million from the Recovery Act to 223 small businesses that are helping the Idaho site complete its Cold War cleanup mission. Examples of these businesses are Hayward Baker, Inc., and Communication Designs.



Workers with small business Hayward Baker, Inc. injected cement-based grout into 21 buried waste locations to stop rain and snow melt from infiltrating the contaminated waste produced during historic operations at the Idaho site.

 - Vendors are able to see the solicitation and get an overview of the anticipated award type
 - Vendors should register into FedConnect in order to get the full benefits of the system such as: submitting questions, receiving emails concerning the solicitation and submitting responses
 - Vendors are able to submit their contract/grant application directly into STRIPES via FedConnect
 - Recommend registering in the Central Contractor Registration (CCR), even if not required
