AMENDATORY PERMIT

AUTHORIZING CITIZENS UTILITIES COMPANY
TO CONSTRUCT, OPERATE, MAINTAIN AND CONNECT
ADDITIONAL ELECTRIC TRANSMISSION FACILITIES
AT THE INTERNATIONAL BORDER BETWEEN
THE UNITED STATES AND MEXICO

(FEDERAL POWER COMMISSION DOCKET NO. E-6432)

Citizens Utilities Company (Permittee), incorporated in Delaware, with its principal office at Stamford, Connecticut, in an application filed in Docket No. E-6432, on May 19, 1955, requested permission to construct, operate, maintain and connect the electric transmission facilities described below at the international border between the United States and Mexico, for the transmission of electric energy from the United States to Mexico. The proposed facilities are in addition to the facilities already constructed and described in the Presidential Permit dated August 8, 1952 in the above docket consisting principally of a 2.3 kv transmission line crossing the international boundary at Nogales, Arizona. The Permittee also filed an application in Docket No. E-6431 for an order pursuant to Section 202(e) of the Federal Power Act for authority to transmit an additional amount of electric energy to Mexico.

By letter dated *Aug 24*, 1955, the Secretary of State and by letter dated *Aug 17*, 1955, the Secretary of Defense, favorably recommended that the permit be granted as hereinafter provided.

Upon consideration of this matter the Federal Power Commission (Commission) finds that the issuance of an Amendatory Permit as hereinafter provided is appropriate and consistent with the public interest.

Article I of the Presidential Permit dated August 8, 1952, is hereby amended to read as follows:

"The Permittee agrees that the facilities herein described shall be subject to all conditions, provisions and requirements of this permit; and that this permit may be modified or revoked at the will and pleasure of the President of the United States, with or without cause. Permittee further agrees that this permit may be modified or revoked by the Federal Power Commission upon a finding that such modification or revocation is necessary in the public interest. Nothing herein shall prevent amendment of this permit upon application to the Commission by the permittee."

Pursuant to the provisions of Executive Order No. 10435, dated September 3, 1953, and the Commission's General Rules and Regulations, permission is hereby granted to Permittee to construct, operate, maintain and connect the electric transmission facilities described below, at the international border between the United States and Mexico:

A three-phase transmission line operating nominally at 13 kv, 60 cycle, located at the international boundary between the State of Arizona and the State of Sonora, Mexico, 1700' east of a 2.3 kv circuit crossing the international boundary at the intersection of Sondita Avenue and the international boundary in Nogales, Arizona.

The additional facilities herein authorized shall be subject to all of the terms and conditions of the Presidential Permit of August 8, 1952,
