SUBJECT: Completion of Waste Removal in Tanks 18 and 19

In accordance with the Federal Facility Agreement (FFA), this letter is to inform you that the U.S. Department of Energy (DOE) considers waste removal completed in Tanks 18 and 19 located in the F-Area Tank Farm. FFA Appendix L Item 9b requires:

- 1. DOE to notify the U.S. Environmental Protection Agency (EPA) and the South Carolina Department of Health and Environmental Control (SCDHEC) when waste removal is completed and to provide supporting documentation for review.
- 2. DOE, SCDHEC and EPA shall mutually agree that waste removal activities may cease.

Accordingly, DOE hereby requests agreement from SCDHEC and EPA that waste removal activities may cease in Tanks 18 and 19. The justification for DOE's decision that waste removal has been completed is provided in the *Industrial Wastewater Closure Module For Liquid Waste Tanks 18 and 19, F-Area Tank Farm Savannah River Site*, SRR-CWDA-2010-00003 and its supporting references, which were provided to SCDHEC.

Also, as required in the *Industrial Wastewater General Closure Plan For F-Area Waste Tank Systems*, LWO-RIP-2009-00009, Rev. 3, an *F-Area Tank Farm Groundwater Monitoring Plan, SRNS-RP-2011-00995* and a *Liquid Waste Tank Residual Sampling and Analysis Program Plan*, SRR-CWDA-2011-00050 and associated *Quality Assurance Program Plan*, SRR-CWDA-2011-00117 have been provided as supporting documentation. As mentioned in the Closure Module, DOE provided SCDHEC a *Data Quality Summary Report*, SRR-CWDA-2011-00150, and reference documents for Tanks 18 and 19 sampling and analysis to provide support and defensibility for the characterization data used.
